Local Board/SART Overview

The local board/SART plans to meet annually with the intent to:

ADVOCACY PROTOCOL

The following seven advocacy services meet core service standards. The following services exist in our county:

∠ 24/7 advocacy, support, and accompaniment during the medical forensic exam, law enforcement investigations and court proceedings
 ∠ Information for victims about reporting/not reporting to law enforcement
 ∠ Crisis intervention and/or emotional support to victims and their families
 ∠ Referrals and coordinated services with other agencies
 ∠ Support for victims through the criminal justice system
 ∠ Replacement clothing for victims after medical forensic exams, if needed
 ∠ Protection of victim privacy and confidentiality

Advocacy services within Wyoming County are provided by Stop Abusive Family Environments (S.A.F.E.). Crisis intervention, advocacy, shelter and support services can be accessed 24/7 by contacting 304-436-8117. S.A.F.E. is the rape crisis center that will be providing follow-up services for victims receiving forensic exams at Raleigh General.

If the victim needs medical care or requests a medical forensic exam, the transportation protocol should be activated and the victim immediately transported for treatment and evidence collection. If the advocate from S.A.F.E. provides the transportation to Raleigh General Hospital, that advocate will also provide advocacy/support services for the victim at the hospital. If transportation to Raleigh General Hospital is provided by EMS or law enforcement, an advocate from AWAY (which provides advocacy services at Raleigh General) will respond within 60 minutes. If a victim is being transported to Raleigh General by EMS or law enforcement, a call can be made to AWAY at 304-255-2559 to alert them to send an advocate.

OVERVIEW

TRANSPORTATION PROTOCOL

OVERVIEW

The SAFE Commission requires that this transportation protocol must include the following four core components:

- 1. Accessible transportation, including the ability to transport victims with disabilities
- 2. Transportation to and from the medical forensic exam regardless of the victim's ability to pay
- 3. Plan for victim confidentiality
- 4. Plan to return the victim to his or her point of origin (or an agreed upon safe place) after the medical forensic examination

Transportation protocol when emergent medical needs exist: Call 911

Transportation protocol when no emergent medical needs exist:

Accessible transportation services are available for victims to Raleigh General Hospital and from the hospital to a safe location by calling Stop Abusive Family Environments (S.A.F.E.). Information will be kept confidential to maintain victim privacy and transportation is available to victims at no cost.

For victims wishing to report the assault immediately to law enforcement or who are in need of medical care, transport services can also be accessed by contacting 911. The Wyoming County Sheriff's Department will provide transportation to the hospital and an incident report will be made. S.A.F.E. will provide free transportation from the hospital to a safe location.
