- Agenda Item 1 April 24, 2025, LEPS minutes were presented for approval.
   Motion made; Sgt. Williams seconded Chief Johnson to approve minutes with
   no noted changes. The motion was approved unanimously without any
   discussion and no negative votes cast.
- Agenda Item 2 LEPS Fund Report was provided by Staff. Motion made, Chief Johnson seconded, Sgt. Williams. The motion was approved unanimously without any discussion and no negative votes cast.
- 3. Agenda Item 3 Consideration of applications for in-service training programs A) Annual In-Service Courses, B) Combined In-Service Courses, motion made, Capt. Goodson seconded, Sgt. Williams to approve both categories and courses. The motion was approved unanimously without any discussion and no negative votes cast.
