**SPECIFICATIONS**

1. **PURPOSE AND SCOPE:** The West Virginia Department of Homeland Security (DHS) - Division of Administrative Services (DAS) is soliciting bids on behalf of the agency West Virginia Correctional Industries (WVCI) to establish an open-end contract to purchase mesh fabric/material for laundry bags and finished and completed laundry bags.
  
2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
  - 2.1. **“Contract Item”** or **“Contract Items”** means the list of items identified in Section 3.1 below and on the Pricing Pages.
  
  - 2.2. **“Pricing Pages”** means the schedule of prices, estimated order quantity, and totals contained in wvOASIS or attached hereto as **Exhibit A**, and used to evaluate the Solicitation responses.
  
  - 2.3. **“Solicitation”** means the official notice of an opportunity to supply the State with goods or services that is published by the Division of Administrative Services (DAS).
  
  - 2.4. **“Denier”** means a unit of measurement for the density of fibers.
  
3. **GENERAL REQUIREMENTS:**
  - 3.1. **Contract Items and Mandatory Requirements:** Vendor must provide Agency with the Contract Items listed below on an open-end basis. Contract Items must meet or exceed the mandatory requirements as shown below.
    - 3.1.1 **Contract Item 1: Mesh Fabric/Material for Landry Bags**
      - 3.1.1.1 Must be of Domestic Goods Only.
      - 3.1.1.2 Must be mesh laundry bag fabric/material, not finished bags.
      - 3.1.1.3 Must be available in colors White and Blue.
      - 3.1.1.4 Must be 100 % high tenacity polyester.
      - 3.1.1.5 Must be 1000 denier.
      - 3.1.1.6 Must weigh a minimum of 5.7 ounces per square yard; maximum 6.1 ounces per square yard.
      - 3.1.1.7 Must be constructed of a minimum of 3.5” x 4.6” courses per inch, hole 3/16” to 1/4”, Instron burst 160 pounds per square inch, with a minimum thickness of 0.045”.
      - 3.1.1.8 Must have allowable shrinkage and shall be a minimum of 1%, heat set up to a minimum 400 degrees Fahrenheit.
      - 3.1.1.9 Mesh fabric/material must be a Medium Firm Finish.

**3.1.1.10** Mash/Fabric Material must be available in rolls at a minimum of 125 to a maximum of 150 yards wrapped in plastic, rolls must be between 60"x 62" wide and must be on skids for unloading.

**3.1.2 Contract Item 2: Finished and Completed Mesh Laundry Bags**

**3.1.2.1** Must be of Domestic Goods Only.

**3.1.2.2** Must be a finished and completed mesh laundry bag.

**3.1.2.3** Must be available in Yellow, Orange, Green, Brown, Red and Purple.

**3.1.2.4** Must not have a draw cord.

**3.1.2.5** Must not have an ID patch.

**3.1.2.6** Must be 100% high tenacity polyester.

**3.1.2.7** Must be 1000 denier.

**3.1.2.8** Must weigh a minimum of 5.7 ounces per square yard; maximum 6.1 ounces per square yard.

**3.1.2.9** Must be constructed of a minimum of 3.5" x 4.6" courses per inch, hole 3/16" to 1/4", Instron burst 160 pounds per square inch, with a minimum thickness of 0.045".

**3.1.2.10** Must have allowable shrinkage and shall be a minimum of 1%, heat set up to a minimum 400 degrees Fahrenheit.

**3.1.2.11** Mesh fabric/material must be a Medium Firm Finish.

**3.1.2.12** Must have a completed mesh bag size of 24" W x 26" L

**3.2.** Samples of the items listed in the RFQ must be available to the Agency upon request after bid opening and before award. Vendor must deliver samples within 5 business days upon request by the Agency. The vendor will be responsible for all shipping and return costs of the samples.

**4. CONTRACT AWARD:**

**4.1. Contract Award:** The Contract is intended to provide Agency with a purchase price on all Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.

**4.2. Pricing Pages:** Vendor must complete the Pricing Pages by providing a unit cost for the Contract Items listed in section 3.1.1 and 3.1.2 of the specifications. Vendor shall include the cost of standard order delivery charges in its bid pricing and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders provided that vendor invoices those delivery costs as a separate charge with the

The Pricing Pages contain a list of the Contract Items and estimated purchase volume. The estimated purchase volume for each item represents the approximate volume of anticipated purchases only. No future use of the Contract or any individual item is guaranteed or implied.

- 4.3** The vendor may, thirty (30) days prior to the contract anniversary date, request a price adjustment. Said price adjustment will be considered based on the prior year CPI compared to the current year CPI, or 3%, whichever is less. Agency must approve all price adjustments prior to implementation.

**5. ORDERING AND PAYMENT:**

- 5.1. Ordering:** Vendor shall accept orders through wvOASIS, regular mail, facsimile, e-mail, or any other written form of communication. Vendor may, but is not required to, accept on-line orders through a secure internet ordering portal/website. If Vendor has the ability to accept on-line orders, it should include in its response a brief description of how Agencies may utilize the on-line ordering system. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.
- 5.2. Payment:** Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

**6. DELIVERY AND RETURN:**

- 6.1. Delivery Time:** Vendor shall deliver standard orders within thirty (30) working for delivery working days after orders are received. Vendor shall deliver emergency orders within fifteen (15) working day(s) after orders are received. Vendor shall ship

all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met.

- 6.2. Late Delivery:** The Agency placing the order under this Contract must be notified in writing if orders will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the delayed order, and/or obtaining the items ordered from a third party.

Any Agency seeking to obtain items from a third party under this provision must first obtain approval of the West Virginia Division of Administrative Services.

- 6.3. Delivery Payment/Risk of Loss:** Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders provided that Vendor invoices those delivery costs as a separate charge with the original freight bill attached to the invoice.
- 6.4. Return of Unacceptable Items:** If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 6.5. Return Due to Agency Error:** Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

7.2. The following remedies shall be available to Agency upon default.

- 7.2.1. Immediate cancellation of the Contract.
- 7.2.2. Immediate cancellation of one or more release orders issued under this Contract.

**8. MISCELLANEOUS:**

**2. MANDATORY TERMS:** The Solicitation may contain mandatory provisions identified by the use of the words "must," "will," and "shall." Failure to comply with a mandatory term in the Solicitation will result in bid disqualification.

Any waiver must be expressly stated in writing and signed by the waiving party.

26. **WARRANTY:** The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.

27. **STATE EMPLOYEES:** State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.

28. **PRIVACY, SECURITY, AND CONFIDENTIALITY:** The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. 29. **YOUR SUBMISSION IS A PUBLIC DOCUMENT:** Vendor's entire response to the Solicitation and the resulting Contract are public documents. **CONSTRUCTION CONTRACTS:** Under W. Va. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

**"Related party"** means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.
