### **SPECIFICATIONS**

- 1. PURPOSE AND SCOPE: The West Virginia Department of Homeland Security Division of Administrative Services (DAS) is soliciting bids on the behalf of the West Virginia Division of Corrections and Rehabilitation (DCR) to establish a one-time contract for the purchase of (3) 40 Gallon Tilt Skillets, or equal for Eastern Regional Jail & Correctional Facility (ERJL&CF) located at 94 Grapevine Road, Martinsburg, WV 25405.
- **2. DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
  - **2.1.** "Contract Item" or "Contract Items" means the list of items identified in Section 3.1 below and on the Pricing Pages.
  - **2.2.** "Pricing Pages" means the schedule of prices, estimated order quantity, and totals contained in wvOASIS or attached hereto as Exhibit A and used to evaluate the Solicitation responses.
  - **2.3.** "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Division of Administrative Services.

### 3. GENERAL REQUIREMENTS:

- **3.1.** Contract Items and Mandatory Requirements: Vendor shall provide Agency with the Contract Items listed below on one-time basis. Contract Items must meet or exceed the mandatory requirements as shown below or equal.
  - 3.1.1 Contract Item 1: Cleveland Forty (40) Gallon Tilt Skillet (Or Equal)
    - **3.1.1.1** Must have a 5/8" stainless steel bead blasted cooking surface to prevent warping and reduce food from sticking.
    - **3.1.1.2** Must have a minimum 40-gallon capacity.
    - **3.1.1.3** Must be minimum 130,000 BTU.
    - **3.1.1.4** Must have liter and gallon markings.
    - **3.1.1.5** Must have a spring-assisted cover with adjustable vent.
    - **3.1.1.6** Must have an anti-splash pouring lip.

    - **3.1.1.9** Must have water-resistant recessed controls.
    - **3.1.1.10** Must have a power jack with splash-proof design to prevent water damage from spillage and cleaning.
    - **3.1.1.11** Must be completely front-serviceable with pull-out componentry.

### 3.2 Alternative 'or Equal' Submission

**3.2.1** Vendor submitting an alternate brand must provide alternate brand information with alternative product number on Pricing Page when submitting bid response. Failure to submit documentation for an "or Equal" product will result in vendor's bid being disqualified.

### 4 CONTRACT AWARD:

- **4.1 Contract Award:** The Contract is intended to provide Agencies with a purchase price for the Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.
- **4.2 Pricing Page:** Vendor shall complete the Pricing Page by providing a unit cost for each Contract Item listed in section 3.1. Vendor shall include the cost of standard order delivery charges in its bid pricing and is not permitted to charge the Agency separately for such delivery. Vendor shall complete the Pricing Page in full as failure to complete the Pricing Page in its entirety will result in the Vendor's bid being disqualified.

Any product or service not on the Agency provided Pricing Page will not be allowable. The state cannot accept alternate pricing pages, failure to use Exhibit A Pricing Page and/or a no-bid will lead to disqualification of vendors bid.

### **5 PAYMENT:**

**5.1 Payment:** Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

### **6 DELIVERY AND RETURN:**

**6.1 Shipment and Delivery:** Vendor shall ship the Contract Items immediately after being awarded this Contract and receiving a purchase order or notice to proceed. Vendor shall deliver the Contract Items within six (6) weeks after receiving a purchase order or notice to proceed. Contract Items must be delivered to:

- **6.2 Late Delivery:** The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party.
- **6.3 Delivery Payment/Risk of Loss:** Vendor shall deliver the Contract Items F.O.B. destination to the Agency's location.
- 6.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 6.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

#### 7 VENDOR DEFAULT:

- **7.1** The following shall be considered a vendor default under this Contract.

  - **7.1.4** Failure to remedy deficient performance upon request.
