**CONSTRUCTION CONTRACTS:** Under W. Va. 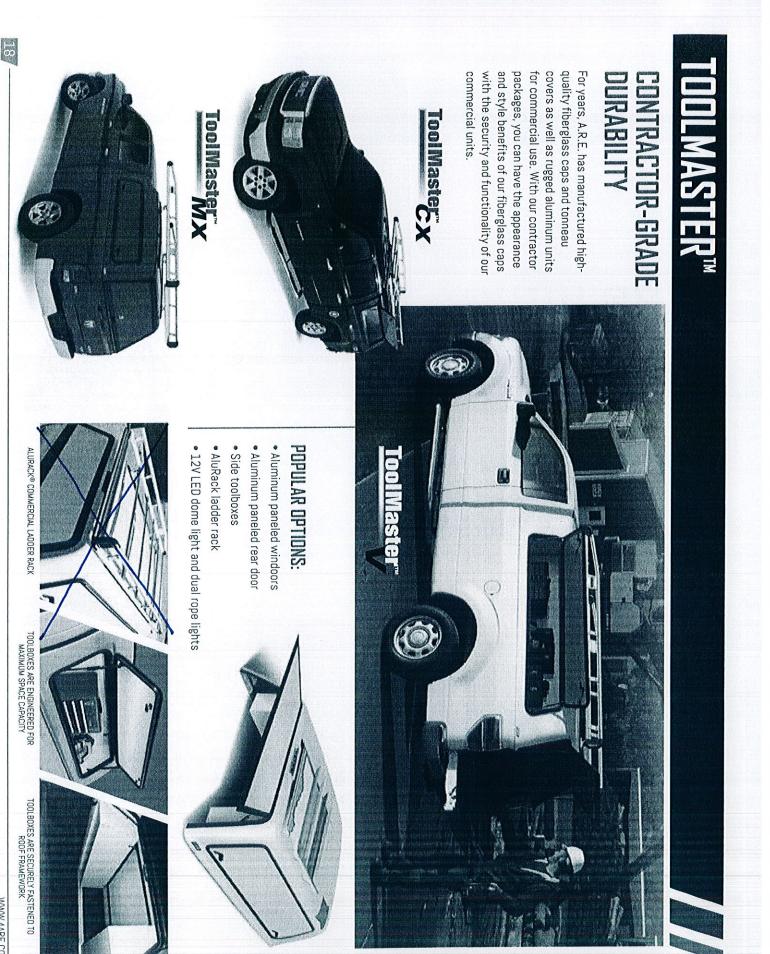
